

With reference to your application No.TET/UM/380/07-08, dated 26<sup>th</sup> October, 2007 requested to grant first time affiliation for the teaching of the courses of study leading to the B.Ed. degree examination from the academic year 2008-09, at Ashok Nagar, Kandivali(E), on the name of the Thakur Shyamnarayan College of Education and Research.

In this connection, I am directed to inform you that considering the report of the Local Inquiry Committee by the Academic Council at its meeting held on 8<sup>th</sup> August, 2008 vide item No. 3.43, I am please to inform you that the Thakur Shyamnarayan College of Education and Research, Thakur Village, Kandivali (E), Mumbai, has been granted first time affiliation on permanent "No Grant Basis" for teaching the course of study of Bachelor of Education (B.Ed.) degree course on the name of Thakur Shyamnarayan College of Education and Research at Opp. Dream Park, Thakur Village, Kandivali (E), Mumbai-400 101 for the academic year 2008-2009.

A copy of the report of the Local Inquiry Committee is enclosed for your information.

The college has to fulfill the conditions mentioned in the letter under reference, issued by the Regional Director, National Council for Teacher Education, Bhopal.

The college has also to fulfill the following affiliation conditions -

- 1) that the conditions laid down by the University from time to time.
- 2) that the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.
- 3) Admissions should not be linked with donations.
- 4) that they will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987, dated 4<sup>th</sup> February, 1987 (copy enclosed.)

- 5) that they should follow the norms as prescribed and circulated by the University vide No.CONCOL/75 of 1988, dated 3<sup>rd</sup> March, 1988 and No.CONCOL/270 of 1989, dated 21<sup>st</sup> July, 1989 (copies enclosed). Further they are requested to recruit the staff as mentioned in the letter issued by the National Council for Teacher Education, Bhopal, before commencement of the course
- 6) the college shall not admit the students over and above sanctioned intake.
- 7) the college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.


Further, I enclose herewith copies of the Circulars No.Aff./Recog./188, dated 17<sup>th</sup> May, 2008 and No.Aff./Recog./189, dated 17<sup>th</sup> May, 2008 for your information and further necessary action.

In case you could not start the College from the academic year 2008-09, the permission granted to your Trust will stand cancelled, which may please be noted.

You are requested to admit the students to the B. Ed. degree course through the Director, Higher Education, Pune for the academic year 2008-09.
